SUMMARY

Issue for Decision (Consent)

Should the Board of Regents approve the proposed appointments of members to New York State Independent Living Council, Inc. (NYSILC)?

Reason(s) for Consideration

The 1992 Amendments to the Rehabilitation Act require the Board of Regents to appoint members to the New York State Independent Living Council, Inc.

Proposed Handling

This issue will come before the Full Board for action at its January 2025 meeting.

Procedural History

Each year, as vacancies occur, the Board of Regents approves recommendations to fill such vacancies.

Recommendation

It is recommended that the Board of Regents take the following action:

VOTED: that Yaw Appiadu be reappointed for a three-year term beginning January 1, 2025, and ending December 31, 2027.

VOTED: that Michael Gilberg be reappointed for a three-year term beginning January 1, 2025, and ending December 31, 2027.

VOTED: that Keith Gurgui be reappointed for a three-year term beginning January 1, 2025, and ending December 31, 2027.

VOTED: that Beata Kaprinska-Prehn be reappointed for a three-year term beginning January 1, 2025, and ending December 31, 2027.

<u>Timetable for Implementation</u>

Upon approval by the Regents of the recommended candidate, the appointments will go into effect retroactive to January 1, 2025.
