SUMMARY

(Federal University of Parana, College of Dentistry, Rio de Janeiro, Brazil, Cirurgiao Dentista, January 1995)

Petition for: Acceptance of education.

<u>Statement of Problem</u>: Section 6604-b of Article 133 of the Education Law requires an applicant for restricted dental faculty license to have completed a total of no less than six academic years of preprofessional and professional education, including: courses in general chemistry, organic chemistry, biology or zoology, and physics; and not less than four academic years of professional dental education satisfactory to the department.

Immediately after secondary school, Dr. Hirata completed a four-year professional dental education program at the Federal University of Parana in Rio de Janeiro, Brazil. Following that, he completed a two-year Master of Dentistry degree in Dental Materials at Pontificia Universidade Catolica do Rio Grande do Sul in Porto Alegre, Brazil, and four-year Doctor of Dentistry degree in Operative Dentistry at Universidade do Estado do Rio de Janeiro in Rio de Janeiro, Brazil.

Although Dr. Hirata has ten years of combined education in dentistry, his education does not exhibit the pattern of two years of preprofessional education followed by a four-year dental program as expected. The Executive Secretary of the State Board for Dentistry recommends that Dr. Hirata's combination of studies be accepted to fulfill the education requirement.

Petition for: Endorsement of applicant's medical license from Canada.

Statement of Problem: Commissioner's Regulations allow endorsement of an applicant's license from another jurisdiction if appropriate requirements are met, and the applicant has not failed any part of New York State's licensing examination. A license granted in a foreign country can be endorsed if licensure in that country is regulated by an organization designated as responsible for quality assurance and acceptable to the Board of Regents. Additionally, the applicant must satisfactorily demonstrate completion of an acceptable proficiency examination, clinical competency examination, three years of American Council on Graduate Medical Education (ACGME) accredited postgraduate training or the equivalent, and five years of satisfactory professional experience.

Dr. Jimenez-Zepeda lacks three years of accredited postgraduate training. The Executive Secretary of the State Board for Medicine has reviewed the documentation submitted in support of Dr. Jimenez-Zepeda's application. He recommends that Dr. Jimenez-Zepeda's training be accepted as the equivalent of the three years of ACGME-accredited postgraduate training required for licensure.

Commissioner's Regulations allow the Board of Regents to accept appropriate foreign medical licenses and diplomate certificates to fulfill the license, proficiency, and clinical competency requirements for New York State licensure by endorsement. Dr. Jimenez-Zepeda obtained his medical license in Canada in 2019. His Canadian license is active and in good standing. Additionally, Dr. Jimenez-Zepeda holds certification specialties in Internal Medicine and Hematology and has passed the Medical Council of Canada Evaluating Examination.

The Executive Secretary of the State Board for Medicine recommends that Dr. Jimenez-Zepeda's Canadian license be endorsed, and his specialty certifications and Medical Council of Canada Evaluating Examination be accepted to fulfill the proficiency and clinical competency requirements for endorsement.

Petition for: Endorsement of applicant's medical license from India.

Statement of Problem: Commissioner's Regulations allow endorsement of an applicant's license from another jurisdiction if appropriate requirements are met, and the applicant has not failed any part of New York State's licensing examination. A license granted in a foreign country can be endorsed if licensure in that country is regulated by an organization designated as responsible for quality assurance and acceptable to the Board of Regents. Additionally, the applicant must satisfactorily demonstrate completion of an acceptable proficiency examination, clinical competency examination, three years of American Council on Graduate Medical Education (ACGME) accredited postgraduate training or the equivalent, and five years of satisfactory professional experience.

Dr. Narayanan lacks three years of accredited postgraduate training. The Executive Secretary of the State Board for Medicine has reviewed the documentation submitted in support of Dr. Narayanan's application. He recommends that Dr. Narayanan's training be accepted as the equivalent of the three years of ACGME-accredited postgraduate training required for licensure.

Commissioner's Regulations allow the Board of Regents to accept appropriate foreign medical licenses and diplomate certificates to fulfill the license, proficiency, and clinical competency requirements for New York State licensure by endorsement. Dr. Narayanan obtained his medical license in India in 2012. His Indian license is active and in good standing. Additionally, Dr. Narayanan is ECFMG certified and holds a Master of Surgery in Ophthalmology certification.

The Executive Secretary of the State Board for Medicine recommends that Dr. Narayanan's Indian license be endorsed, and his Master of Surgery in Ophthalmology certification be accepted to fulfill the clinical competency requirements for endorsement.

<u>Summary Statement</u>: The petitioners listed below are all graduates of foreign medical schools who have been licensed in New York.

The applicable requirements of Section 3.57 of the Rules of the Board of Regents require completion of a medical education program in a foreign medical school satisfactory to the Department which does not grant the degree Doctor of Medicine (M.D.), and in which the philosophy and curriculum were equivalent, as determined by the Department in accordance with the policy of the Board of Regents, to those in programs leading to the degree Doctor of Medicine (M.D.) at medical schools in the United States satisfactory to, or registered by, the Board of Regents and the Department. Secondly, petitioners must have licensure to practice medicine in New York State in accordance with provisions of Section 6524 or 6528 of the Education Law or their equivalent as determined by the Board of Regents pursuant to their authority under Section 6506 of the Education Law.
