SUBJECT: Proposed Amendment of Section 64.7 of the Regulations

of the Commissioner of Education Relating to the Execution by Registered Professional Nurses of Non-Patient Specific Orders to Provide Certain Emergency Medical Services and Administer Pregnancy Tests

SUMMARY

<u>Issue for Decision</u>

Should the Board of Regents adopt the proposed amendment of section 64.7 of the Regulations of the Commissioner of Education relating to the execution by registered professional nurses of non-patient specific orders to provide certain emergency medical services and administer pregnancy tests?

Reason for Consideration

Required by State statute (Chapter 520 of the Laws of 2024) and a review of policy.

Proposed Handling

The proposed amendment will be presented to the Professional Practice Committee for discussion and recommendation to the Full Board for adoption as an emergency action at the February 2025 Regents meeting. A copy of the proposed rule (Attachment A) and a statement of facts and circumstances justifying the emergency action (Attachment B) are attached.

Procedural History

A Notice of Emergency Adoption and Proposed Rule Making will be published in the State Register on February 26, 2025 for a 60-day public comment period. Supporting materials for the proposed rule are available upon request from the Secretary to the Board of Regents.

Background Information

Currently, registered professional nurses (RNs) can execute non-patient specific orders and protocols, ordered or prescribed by licensed physicians (physicians) or certified nurse practitioners (NPs), but not physician assistants (PAs), to provide certain medical services, including emergency services and administering pregnancy tests.

Chapter 520 of the Laws of 2024 (Chapter 520), effective February 22, 2025, addresses this issue by authorizing RNs to execute non-patient specific orders and protocols, ordered or prescribed by PAs to provide the following medical services: (1) administering immunizations; (2) emergency treatment of anaphylaxis; (3) administering purified protein derived (PPD) tests or other tests to detect or screen for tuberculosis infections; (4) administering tests to determine the presence of the human immunodeficiency virus (HIV); (5) administering tests to determine the presence of the hepatitis C virus; (6) urgent or emergency treatment of opioid related overdose or suspected opioid related overdose; (7) screening of persons at increased risk of syphilis, gonorrhea, and chlamydia; (8) administering electrocardiogram tests to detect signs and symptoms of acute coronary syndrome; (9) administering point-of-care blood glucose tests to evaluate acute mental status changes in persons with suspected hypoglycemia; (10) administering tests and intravenous lines to persons that meet severe sepsis and septic shock criteria; (11) administering tests to determine pregnancy; and (12) administering tests to determine the presence of COVID-19 or its antibodies or influenza virus. These medical services, including emergency medical services, as recognized in Chapter 520, do not supplant the authority of the attending practitioner, the hospital, the Public Health Law or regulations of the Department of Health.

Proposed Amendment

The proposed amendment implements Chapter 520 by amending section 64.7 of the Commissioner's regulations to authorize PAs to prescribe and order a non-patient specific regimen to RNs to provide the above-referenced medical services.

The proposed amendment also:

- changes all the references to "him or her" in section 64.7 of the Commissioner's regulations to "them;"
- corrects a citation error in section 64.7(d)(1) of the Commissioner's regulations; and
- adds cross-citations to section 64.7(i)(1)(iii) of the Commissioner's regulations to assist stakeholders in finding the definition and requirements for non-patient specific orders and protocols prescribed or ordered by a physician, PA or NP for providing emergency medical care for patients.

Related Regents Items

Not applicable.

Recommendation

It is recommended that the Board of Regents take the following action:

VOTED: That section 64.7 of the Regulations of the Commissioner of Education be amended, as submitted, effective February 22, 2025, as an emergency action upon a finding by the Board of Regents that such action is necessary for the preservation of the public health and general welfare to timely conform the Commissioner's regulations to implement the requirements of Chapter 520 of the Laws of 2024, which becomes effective February 22, 2025.

<u>Timetable for Implementation</u>

If adopted as an emergency rule at the February 2025 Regents meeting, the emergency rule will become effective on February 22, 2025. It is anticipated that the proposed amendment will be presented to the Board of Regents for permanent adoption at the June 2025 meeting, after publication in the State Register and the expiration of the 60-day public comment period required under the State Administrative Procedure. Because the action will expire before the June 2025 meeting, it is anticipated that an additional emergency action will be presented for adoption at the May 2025 Regents meeting. If adopted at the June 2025 Regents meeting, the proposed rule will become effective June 25, 2025

Attachment B

STATEMENT OF FACTS AND CIRCUMSTANCES WHICH NECESSITATE EMERGENCY ACTION

The proposed rule is necessary to implement Chapter 520 of the Laws of 2024, which becomes effective February 22, 2025, and authorizes registered professional nurses (RNs) to execute non-patient specific orders and protocols, ordered or prescribed by licensed physician assistants (PAs) to provide the following medical services:(1) administering immunizations; (2) emergency treatment of anaphylaxis; (3) administering purified protein derived (PPD) tests or other tests to detect or screen for tuberculosis infections; (4) administering tests to determine the presence of the human immunodeficiency virus (HIV); (5) administering tests to determine the presence of the hepatitis C virus; (6) urgent or emergency treatment of opioid related overdose or suspected opioid related overdose; (7) screening of persons at increased risk of syphilis, gonorrhea, and chlamydia; (8) administering electrocardiogram tests to detect signs and symptoms of acute coronary syndrome; (9) administering point-of-care blood glucose tests to evaluate acute mental status changes in persons with suspected hypoglycemia; (10) administering tests and intravenous lines to persons that meet severe sepsis and septic shock criteria; (11) administering tests to determine pregnancy; and (12) administering tests to determine the presence of COVID-19 or its antibodies or influenza virus.

The proposed amendment implements Chapter 520 by amending section 64.7 of the Commissioner's regulations to authorize PAs to prescribe and order a non-patient specific regimen to RNs to provide the above referenced medical services.

Since the Board of Regents meets at fixed intervals, the earliest the proposed rule can be presented for permanent adoption, after the expiration of the required 60-day comment period as provided for in sections 201(1) and 201(5) of the State Administrative Procedure Act (SAPA), would be the June 2025 Regents meeting. Furthermore, pursuant to SAPA 203(1), the earliest effective date of the proposed rule, if adopted at the June meeting, would be June 25, 2025, the date the Notice of Adoption would be published in the State Register. Therefore, emergency action is necessary at the February 2025 meeting for the preservation of the public health and general welfare to timely implement the provisions of Chapter 520, which becomes effective February 22, 2025.

It is anticipated that the proposed rule will be presented for permanent adoption at the June 2025 Regents meeting, which is the first scheduled meeting after expiration of the 60-day public comment period mandated by SAPA for State agency rule makings. However, since the emergency action will expire before the June Regents meeting, it is anticipated that an additional emergency action will be presented for adoption at the May 2025 Regents meeting.
